Monticello Extended Power Uprate (EPU) Acceptance

By application dated November 5, 2008, the licensee requested a 13% EPU for Monticello Nuclear Generating Plant. By letter dated December 18, 2008, the NRC informed the licensee that the application provides technical information in sufficient detail to enable the staff to proceed with the detailed technical review. The application requests NRC approval of the amendment by December 1, 2009, and plans to implement the EPU in two phases (the first phase within 120 days of NRC approval and the second phase in 2011).
