Extended Shutdown at Nuclear Fuel Services (NFS)

On December 30, 2009, NRC received a letter of commitment from NFS detailing their plans to take certain actions before restarting operations. Region II staff had previously contacted NFS to discuss the findings of an Augmented Inspection Team which investigated an unexpected exothermic reaction that occurred on October 13, 2009 and the need for NFS to take certain actions before operations (shutdown for the holidays) were restarted. Region II staff is preparing a Confirmatory Action Letter and a communications plan.

Additionally, NMSS has contacted its counterparts in the National Nuclear Security Administration (NNSA) regarding the need for an extended shutdown at NFS. NNSA promised to evaluate the impact of the shutdown on its programs and inform the NRC if it identified a significant problem.

Meeting with Alpha Omega Services (AOS)

On December 22, 2009, NMSS, Division of Spent Fuel Storage and Transportation staff met with AOS to provide clarification on the staff's request for additional information (RAI) for the Model Nos. AOS-25, AOS-50 and AOS-100 packages. Staff discussed the quality of the revised Safety Analysis Report (SAR) (e.g., inconsistent values and parameters throughout the SAR; even after a request for supplemental information). AOS pledged to work diligently on their responses to staff's request for additional information. This is a Priority 2 application and staff has been using a staggered RAI process to give as much time as possible to AOS to prepare satisfactory responses.
