Publication of Regulatory Guide (RG) 4.16, "Monitoring and Reporting Radioactive Materials in Liquid and Gaseous Effluents from Nuclear Fuel Cycle Facilities"

On December 28, 2010, RES staff published RG 4.16, revision 2, "Monitoring and Reporting Radioactive Materials in Liquid and Gaseous Effluent from Nuclear Fuel Cycle Facilities." This guide describes a method that the NRC considers acceptable for the development and implementation of effluent monitoring programs described in license applications and for monitoring and reporting effluent data by licensees. The guidance is applicable to nuclear fuel cycle facilities, with the exception of uranium milling facilities and nuclear power reactors.
