Federal Energy Regulatory Commission (FERC) Dam Inspections

From April 4 - 8, 2011, staff and dam inspectors from performed dam safety inspections at the McGuire, Catawba, VC Summer, and Shearon Harris Nuclear Power Plants. The staff's overall assessments concluded that the dam and appurtenant structures for all four sites appeared to be in satisfactory condition and were adequately maintained; however, a few routine maintenance issues were identified. An inspection report for each of the sites will be issued in the near future.

American Society of Mechanical Engineers (ASME) Nuclear Quality Assurance (NQA)-1 Committee Meetings

On April 12 -14, 2011, staff participated in ASME NQA-1 working groups, the Software QA task group, six Subcommittees, the Main Standards Committee, and Executive Committee meetings in Nashville, Tennessee. The staff continues to address commercial-grade dedication and other technical issues related to computer software quality assurance identified in the ASME NQA-1-2008 Edition and the NQA-1a- 2009 addenda. Also, the Software Quality Assurance Subcommittee has begun actions to revise Part II, Subpart 2.7, "Quality Assurance Requirements for Computer Software for Nuclear Facility Applications", and is developing a guideline to support the dedication of acquired software.

Issuance of the Renewed Operating License for Palo Verde Nuclear Generating Station

On April 21, 2011, the operating licenses for the Palo Verde Nuclear Generating Station, Units 1, 2, and 3, were renewed, authorizing operation for an additional 20 years beyond the original license expiration dates. The new expiration dates are June 1, 2045, for Unit 1; April 24, 2046, for Unit 2; and November 25, 2047, for Unit 3. The staff completed its review as documented in the Safety Evaluation Report, NUREG-1961, published April 2011, and the Supplemental Environmental Impact Statement, NUREG-1437, Supplement 43, published January 2011. The issuance of the Palo Verde Nuclear Generating Station renewed licenses brings the total number of renewals to 66 reactor units.

Fire Protection Meeting on National Fire Protection Association (NFPA) 805 Frequently Asked Questions (FAQs)

On April 21, 2011, the staff held a Category 2 public meeting with the Nuclear Energy Institute NFPA Standard 805 Task Force, other stakeholders, and the public, to discuss the FAQs related to licensees' adoption of NFPA 805. The staff began holding these monthly public meetings in July 2006.

Public Meeting with Nuclear Energy Institute, Fuel Cycle Licensees and Certificate Holders

On April 14, 2011, staff from NMSS led a public meeting with representatives of the Nuclear Energy Institute and fuel cycle licensees and certificate holders to discuss enhancements to the fuel cycle oversight process. Staff from Region II and the Office of Enforcement also participated. The topics addressed in this public meeting included the process to provide licensees with credit for an effective corrective action program, draft information on the developed safety-related cornerstones, and a high-level discussion on the path forward.

AREVA Eagle Rock Enrichment Facility Construction Schedule

On April 21, 2011, AREVA Enrichment Services (AES) provided advance notice to the NRC project manager that they expect to delay initiating construction of the proposed Eagle Rock Enrichment Facility until calendar year 2012. AES's construction schedule assumed that they would begin pouring concrete in August 2011, shortly after the anticipated completion of the mandatory hearing and receipt of a license. Given that the Atomic Safety Licensing Board (ASLB) announced a July hearing date for the environmental issues and scheduled their decision to be issued in the September – November timeframe, AES has decided not to initiate construction activities until early 2012. AES is working with its contractor and vendors to develop a revised construction schedule for the project.

Controlled Unclassified Information (CUI) Working Group

On April 13, 2011, OIS staff participated in a CUI Working Group meeting sponsored by the CUI Executive Agent (EA). The purpose of the meeting was to discuss the latest changes to the draft CUI Implementing Directive, which included changes based on meetings with the private sector and public interest groups, and comments from agencies that have not been participating in the working groups. This was the last meeting on the initial implementing directive. After agencies submit their proposed CUI markings, categories, and subcategories to the EA on May 3, 2011, the EA will form new working groups related to specific CUI categories and subcategories. These new working groups will try to standardize the safeguarding and dissemination criteria to the lowest common denominator for all agencies. The NRC will be invited to participate in these groups.
