Personnel Security Support

On June 2, 2011, as a result of a non-competitive 8(a) Request for Proposal, a hybrid labor-hour contract with one optional firm-fixed-price line item (NRC-HQ-11-C-10-0046) was awarded to AQIWO, Inc. of Arlington, Virginia. The contractor provides the NRC's Personnel Security Branch, Division of Facilities and Security, Office of Administration, with onsite administrative security support services. The period of performance is from July 17, 2011, to November 30, 2011, with three 1-year option periods. The total cost of the contract is \$3,241,812.26, inclusive of the line item and term options.

Technical Assistance for Evaluating License Amendment Requests Related to Transition to the New Risk-Informed Fire Protection Licensing Basis

On June 10, 2011, as a result of a noncompetitive acquisition, a cost-plus-fixed-fee type contract (NRC-HQ-11-C-03-0047) was awarded to Southwest Research Institute of San Antonio, Texas, to provide technical assistance in evaluating license amendment requests related to transition to the new risk-informed fire protection licensing basis. The period of performance is from June 10, 2011, to September 28, 2012, with three 1-year option periods. The total cost of the contract is \$3,005,465.00 inclusive of options.

Draft Regulatory Basis for a Potential Rulemaking on Spent Nuclear Fuel Reprocessing Facilities, Proposed Rule; Public Meeting and Request for Comments - 10 CFR Part 50 (NRC-2010-0267)

On June 10, 2011, the NRC published a meeting notice (76 FR 34007) in the *Federal Register* regarding a 2-day public meeting on June 21, 2011, and June 22, 2011, from 9:00 a.m. to 5:00 p.m. in Augusta, Georgia, to solicit input on issues associated with the development of a draft regulatory basis document for a potential rulemaking on spent nuclear fuel reprocessing facilities.

Vulnerability and Threat Information for Facilities Storing Spent Nuclear Fuel and High-Level Radioactive Waste, Public Meeting - 10 CFR Parts 72 and 73 (NRC-2009-0558)

On June 16, 2011, the NRC posted a notice for a public meeting (76 FR 35137) in the *Federal Register* to discuss with affected stakeholders vulnerability and threat information associated with the forthcoming security rulemaking. This information will be used to inform the regulatory basis for the rulemaking, and new risk-informed and performance-based security regulations for Spent Nuclear Fuel and High-Level Radioactive Waste storage facilities will be issued. The draft regulatory basis was published for comment in the *Federal Register* on December 16, 2009 (74 FR 66589). The meeting will be held on July 26, 2011, from 9:00 a.m. to 4:00 p.m. in Rockville, Maryland, and will be closed under exemptions 3.a and 3.b of the Commission's policy statement, due to the expected discussion of classified information.

Public Meeting on the Performance Demonstration Initiative (PDI)

From June 6-7, 2011, staff conducted a Category 2 public meeting with representatives from the PDI to discuss various aspects of implementation requirements for the American Society of Mechanical Engineers (ASME) Boiler and Pressure Vessel Code (Code), Section XI, Appendix VIII. Discussions included a current status of ASME Code-related activities, NRC rulemaking activities, program status updates, cast austenitic stainless steel examination capabilities and plans, and continuing research activities.

GE-Hitachi (GEH) Nuclear Energy Topical Report

On June 7, 2011, staff presented results of their review of GEH Topical Report NEDC-33173P, Revision 2 and Supplement 2, Parts 1-3, "Analysis of Gamma Scan Data and Removal of Safety Limit Critical Power Ratio Margin." This topical report was submitted by GEH to further qualify their analytical methods and requests removal of two limitations imposed in the NRC staff's approval of NEDC-33173P-A, "Applicability of GE Methods to Expanded Operating Domains."

Public Meeting with Electric Power Research Institute (EPRI) Materials Reliability Program

From June 8-10, 2011, staff conducted a well-attended Category 2 public meeting with representatives from industry, the EPRI Materials Reliability Program (MRP), and the Boiling Water Reactor Vessel Integrity Program to discuss various aspects of primary systems materials. Discussions included material programs, pressurized-water reactor vessel internals inspection; nondestructive examination; nickel alloy welding; operating experience; MRP action plans relating to cold pressurized-water reactor heads; and updates of NRC activities such as the Generic Aging Lessons Learned report, second license renewals, and the extremely low probability of rupture code development.

Institute of Electrical and Electronics Engineers Meeting in Sweden

From June 13-17, 2011, staff participated in joint meeting with the Institute of Electrical and Electronics Engineers (Subcommittee 2) and International Electrotechnical Commission in Gothenburg, Sweden. The purpose of the meeting was to develop and integrate technical standards related to the environmental qualification of electrical equipment.

RES Public Meeting on Weld Residual Stress (WRS) Finite Element Analysis (FEA) Validation

On June 14-15, 2011, RES hosted a Category 2 Public Meeting with representatives from RES and the Office of Nuclear Reactor Regulation (NRR), RES contractors, and seven organizations representing the U.S. and French nuclear power industries regarding the WRS FEA validation program. The meeting focused on FEA modeling techniques of dissimilar metal welds and comparisons to measurements taken on various mockups and actual plant components. The program yielded many insights into the specific contributions of various parameters to WRS FEA calculations.
