Miscellaneous Administrative Changes; Final Rule, 10 CFR Parts 1, 9, 19, 20, 30, 35, 40, 52, 55, 60, 61, 70, 73, 110, 170, and 171 (RIN 3150-AJ01; NRC-2011-0169)

On November 22, 2011, the NRC published a final rule in the *Federal Register* (76 FR 72082) amending its regulations to make miscellaneous administrative changes, including updating the street address for its Region IV office and correcting an authority citation and typographical and spelling errors, and other edits and conforming changes. This document is necessary to inform the public of these changes to the NRC's regulations. This rule is effective December 22, 2011.

Enhancements to Emergency Preparedness (EP) Regulations; Final Rule, 10 CFR Parts 50 and 52 (RIN 3150-A110; NRC-2008-0122)

On November 23, 2011, the NRC published a final rule in the *Federal Register* (76 FR 72560) amending certain EP requirements in its regulations that govern domestic licensing of production and utilization facilities. The final rule adds a conforming provision in the regulations that govern licenses, certifications, and approvals for new nuclear power plants. The final rule codifies certain voluntary protective measures contained in NRC Bulletin 2005-02, "Emergency Preparedness and Response Actions for Security-Based Events," and generically applicable requirements similar to those previously imposed by Commission orders. The amended licensee emergency plan requirements enhance the ability of licensees in preparing to take and taking certain EP and protective measures in the event of a radiological emergency; address, in part, security issues identified after the terrorist events of September 11, 2001; clarify regulations to effect consistent emergency plan implementation among licensees; and modify certain EP requirements to be more effective and efficient. This final rule is effective on December 23, 2011.

Office of Management and Budget (OMB) Meeting on Paperwork Reduction Act

On November 22, 2011, the Deputy Executive Director for Corporate Management; the Director, Office of New Reactors; and the NRC Paperwork Reduction Act Clearance Officer met with the Deputy Administrator, Office of Information and Regulatory Affairs (OIRA), OMB. Also present were the Chief, Natural Resources and Environment Branch, OIRA, and OMB's NRC Desk Officer. The meeting, at OMB's request, regarded prioritization of the new reactors rulemakings and NRC's concerns about OMB's ability to complete these actions on NRC's schedule. An alternative approach was discussed for meeting NRC's deadlines for multiple submissions of information collection approvals for the design certification rulemakings. OMB was very responsive to NRC's needs and agreed to review NRC's proposed deadlines on a case-by-case basis. NRC will provide a detailed list of upcoming actions to assist OMB in prioritizing its workload to meet NRC's proposed deadlines.

Meeting with Electric Power Research Institute and Performance Demonstration Initiative (PDI)

On November 15-17, 2011, staff, along with personnel from the Pacific Northwest National Laboratory, met with the members from the Electric Power Research Institute and PDI to discuss the ability to size flaws during qualification examinations for the American Society of Mechanical Engineers Boiler and Pressure Vessel Code (ASME Code), Section XI, Appendix VIII, qualification requirements. Specific discussions focused on the accuracy of sizing flaws from the inner diameter for large bore weld examinations and the inability to achieve the accuracy requirements in the ASME Code. The data collected during qualification testing was reviewed to determine if there were any correlations to surface condition, material, etc. that result in the inability to meet the standards.
