NRC Headquarters Operations Center Equipment Purchase

On September 27, 2012, as a result of a non-competitive 8(a) solicitation, a time and materials contract (NRC-HQ-12-C-07-0125) was awarded to Technology Specialist, Inc., of Bowie, MD for turnkey installation of an audio visual display system at the NRC Headquarters Operation Center. The period of period is September 28, 2012, to March 27, 2014 with no option periods. The total estimated cost is \$1,173,815.78.

Operation of 3WFN Cafeteria

On October 18, 2012, as a result of a competitive acquisition, a contract (NRC-HQ-12-C-10-0067) was awarded to Corporate Chefs, Inc. of Haverhill, MA for operation of the Three White Flint North cafeteria. The period of performance is January 14, 2013, to January 13, 2014, with four 1-year option periods. The total estimated revenue is \$3,000,000 inclusive of options.

Branch Technical Position on the Import of Non-U.S. Origin Radioactive Sources; 10 CFR Part 110 (NRC-2012-0008)

On October 22, 2012, the NRC published a document in the *Federal Register* (77 FR 64435) requesting comment on a Branch Technical Position (BTP) on the import of non-U.S. origin radioactive sources. Since publication of a final rule (75 FR 44072; July 28, 2010) amending 10 CFR part 110 to improve NRC's regulatory framework for the export and import of nuclear equipment, material and radioactive waste, NRC staff has been engaged with industry in response to concerns raised regarding established industry practices and the need for guidance on implementation of the "U.S. origin" exclusion. The deadline to submit comments on the BTP is December 21, 2012.

Consideration of Environmental Impacts of Temporary Storage of Spent Fuel After Cessation of Reactor Operation; 10 CFR Part 51 (3150-AJ20; NRC-2012-0246)

On October 25, 2012, the NRC published a document in the *Federal Register* (77 FR 65137) notifying the public that it is updating its Waste Confidence Decision and Rule. The NRC intends to prepare an Environmental Impact Statement (EIS) to support the rulemaking to update the Commission's Waste Confidence Decision and Rule, and is conducting a scoping process to gather information necessary to prepare the EIS. As part of the scoping process the NRC is planning to hold two public meetings on November 14, 2012, and two webinars on December 5 and 6, 2012. The deadline to submit comments is January 2, 2013.
