International Atomic Energy Agency meeting on the Application of Safeguards to Geological Repositories

From October 29-30, 2012, NRC staff participated as experts for the International Atomic Energy Agency (IAEA) meeting on the Application of Safeguards to Geological Repositories (ASTOR) hosted in Vienna, Austria. The purpose of the 8<sup>th</sup> ASTOR Experts Meeting was to provide a forum for the IAEA to describe its technical needs and concepts for implementing international safeguards at the first spent fuel encapsulation plant and geological repository. During the meeting the IAEA also identified where the ASTOR Experts Group could further contribute to the IAEA's efforts for the application of safeguards to geological repository facilities.
