Non-Dedicated Office/Meeting Space

On August 29, 2013, as a result of a competitive solicitation, an indefinite delivery/indefinite quantity contract (NRC-HQ-13-C-10-0053) was awarded to CX International, Inc. of Washington, DC, for non-dedicated office/meeting space. The period of performance is from September 1, 2013, to August 31, 2014, with four 1-year option periods. The total value of the contract is \$153,983, inclusive of all options.

Analysis of Cancer Risks in Populations Near Nuclear Facilities: Phase 2

On August 30, 2013, a grant (NRC-HQ-13-G-04-0051) was awarded to the National Academy of Sciences of Washington, DC. The National Research Council will perform a pilot study of cancer risks in populations near seven NRC-licensed nuclear facilities using two epidemiologic study designs: (i) an ecologic study of multiple cancer types of populations of all ages; and (ii) a record-linkage-based case control study of cancers in children. The period of performance is from September 1, 2013, to August 31, 2014, with no options. The total value of the grant is \$564,600.

Issuance of Davis-Besse Final Safety Evaluation Report

On September 3, 2013, the staff issued the final Safety Evaluation Report (SER) (ML13248A267) related to the Davis-Besse Nuclear Power Station, Unit 1, license renewal application (LRA), which FirstEnergy Nuclear Operating Co. submitted to the NRC in August 2010. The final SER summarizes the results of the staff's safety review of the LRA in accordance with Title 10 of the Code of Federal Regulations, Part 54, "Requirements for Renewal of Operating Licenses for Nuclear Power Plants," and describes the technical details considered in evaluating the proposed operation of the plant for an additional 20 years beyond the term of the current operating license. The staff is scheduled to meet with the Advisory Committee on Reactor Safeguards (ACRS) subcommittee on November 21, 2013, and the final ACRS meeting is scheduled for December 5, 2013.
