List of Approved Spent Fuel Storage Casks: HI-STORM 100 Cask System; Amendment No. 9: Direct Final Rule; 10 CFR Part 72 (RIN 3150-AJ12; NRC-2012-0052)

On December 6, 2013, the U.S. Nuclear Regulatory Commission (NRC) published a direct final rule in the *Federal Register* ([78 FR 73379](#)) amending its spent fuel storage regulations by revising the Holtec International HI-STORM 100 Cask System listing within the “List of Approved Spent Fuel Storage Casks” to include Amendment No. 9 to Certificate of Compliance No. 1014. Amendment No. 9 broadens the subgrade requirements for the HI-STORM 100U part of the HI-STORM 100 Cask System and updates the thermal model and methodology for the HI-TRAC transfer cask from a two dimensional thermal-hydraulic model to a more accurate three-dimensional model. The amendment also makes editorial corrections. The direct final rule will become effective on February 19, 2014, unless significant adverse comments are received on the companion proposed rule ([78 FR 73456; December 6, 2013](#)) by January 6, 2014.

Miscellaneous Corrections; Corrections: Correcting Amendments; 10 CFR Parts 40, 50, 52, and 70 (RIN 3150-AJ23; NRC-2013-0019)

On December 12, 2013, the NRC published a document in the *Federal Register* ([78 FR 75449](#)) making miscellaneous corrections to a final rule ([78 FR 34245](#)) published on June 7, 2013. The final rule contained minor errors in grammar, punctuation, and referencing. This document corrects the final rule by amending the sections that contain these errors .
