Office of Nuclear Regulatory Research Publication of Draft Regulatory Guide (DG)-3044, Revision 0 of a new Regulatory Guide, “Corrective Action Programs for Fuel Cycle Facilities”

On February 12, 2014, the staff announced the release of Draft Regulatory Guide (DG)-3044, “Corrective Action Programs for Fuel Cycle Facilities,” to provide the public an opportunity to comment on the proposed new Regulatory Guide. DG-3044 provides information for applicants and licensees on activities that the staff considers acceptable for corrective action programs for fuel cycle facilities licensed under 10 CFR Parts 40, or 70, and gaseous diffusion plants under 10 CFR Part 76. The DG is available in the NRC’s Agencywide Documents Access & Management System (ADAMS) using Accession No. ML13219B204. The announcement has been published in the *Federal Register* (79 FR 8511).
