SUBJECT: STAFF REQUIREMENTS – SECY-11-0002 – PROPOSED RULE:

AP1000 DESIGN CERTIFICATION AMENDMENT (RIN 3150-

AI81)

The Commission has approved the proposed amendment to 10 CFR Part 52 for publication in the *Federal Register*, subject to the changes noted below.

As a separate matter from the rulemaking, the staff is encouraged to participate, as appropriate and resources permit, in efforts by the American Concrete Institute or other consensus standard organization regarding design and construction of steel-concrete composite structures that form part of a nuclear power plant and that have nuclear safety-related functions.
