**I. SECY-00-0138 - Private Fuel Storage, L.L.C., Docket No. 72-22, Referred Ruling of LBP-00-06**

The Commission approved a Memorandum and Order, referred to the Commission pursuant to 10 CFR § 2.730(f), granting discretionary review and affirming in part, reversing in part, and remanding the financial assurance issue to the Board for further proceedings.

(Subsequently, on August 1, 2000, the Secretary signed the Memorandum and Order.)

**III. SECY-00-0150 - Northern States Power Co. (Monticello Nuclear Generating Plant; Prairie Island Nuclear Generating Plan, Units 1 and 2; and Prairie Island Independent Fuel Storage Installation); Docket Nos. 50-263-LT, 50-282-LT, 50-306-LT, 70-10-LT; Petitions to Intervene**

The Commission approved a Memorandum and Order responding to petitions filed by Ms. Carol A. Overland, the North American Water Office, and the Prairie Island Indian Community related to the transfer of the operating licenses for three facilities -- Monticello and Prairie Island units 1 and 2; and the materials license for the Prairie Island Independent Fuel Storage Installation. The Memorandum and Order (1) denies the petitions to intervene and requests for hearing filed by Ms. Overland, the North American Water Office, and the Prairie Island Indian Community; (2) dismisses as moot Ms. Overland's request for consolidation; and (3) authorizes the petitioners to file a consolidated request for reconsideration within ten days of the date of this order, and further authorizes Northern States to file a response within ten days of receiving petitioners' request.
