CHAIRMAN MESERVE: Why don't we get started? We're here this morning for an affirmation session. Before I turn this matter over to the Secretary, would any of my colleagues like to make an opening statement?

COMMISSIONER MERRIFIELD: No.

CHAIRMAN MESERVE: If not, Madam Secretary, you may proceed.

MS. VIETTI-COOK: The Commission has voted to approve a Memorandum and Order which vacates LBP-99-45, grants GPU's request to withdraw without prejudice its license amendment application, and terminates the proceeding. Would you please affirm your vote?

CHAIRMAN MESERVE: Aye.

COMMISSIONER DICUS: Aye.

COMMISSIONER MCGAFFIGAN: Aye.

COMMISSIONER MERRIFIELD: Aye.

MS. VIETTI-COOK: Had Commissioner Diaz been here he would have affirmed the Memorandum and Order as well. The second item the Commission is being asked to act on is a Memorandum and Order involving a September 10, 1999, license transfer application by AmerGen Energy Company, Niagara Mohawk Power Corporation and the New York State Electric and Gas Corporation regarding Units 1 and 2 of the Nine Mile Point nuclear generating facility. The Commission has voted to approve a Memorandum and Order which grants standing to the co-owners of Nine Mile

Point, Unit 2, permits the New York Attorney General to participate in a manner analogous to a participating government under 10 CFR Part 2.715(c) should a hearing be granted, rejects co-owners' "suggestion" that formal hearing procedures be applied in this case, and provides a short suspension of the proceeding. Would you please affirm your vote?

CHAIRMAN MESERVE: Aye.

COMMISSIONER DICUS: Aye.

COMMISSIONER MCGAFFIGAN: Aye.

COMMISSIONER MERRIFIELD: Aye.

MS. VIETTI-COOK: Again, had Commissioner Diaz been here he would have affirmed this Memorandum and Order as well.

CHAIRMAN MESERVE: Are there any other matters you want to bring to our attention?

MS. VIETTI-COOK: No.

CHAIRMAN MESERVE: If not, do we have any closing statements by my colleagues?

CHAIRMAN MESERVE: Then we stand adjourned.
