- **As We Further Transition Into New Reactor Oversight Process, and Consistent With SECY-99-086 and SECY-00-0049, Regional-Focus Classification Has Been Eliminated For May 2000 SMM**
- **Going Forward, Agency-Focus and Routine Oversight Terms Will No Longer Be Used - - Level of Regulatory Oversight and Actions Will Be Commensurate with ROP Action Matrix**

- **Status of Plants Discussed During the April 1999 SMM**

TRANSITION SMM PROCESS - DEFINITION OF TERMS

- ***Agency-Focus*** - Plants Requiring the Direct Attention and/or Involvement by the EDO and/or Commission to Coordinate NRC Resources and Maintain Cognizance of Licensee Performance
- ***Routine Oversight*** - Plants Receiving Oversight Under the Auspices of the NRC's Inspection Manual Chapter 2515, "Light-Water Reactor Inspection Program - Operations Phase"

AGENCY-FOCUS

PLANTS REQUIRING THE DIRECT ATTENTION AND/OR INVOLVEMENT BY THE EDO AND/OR COMMISSION TO COORDINATE NRC RESOURCES AND MAINTAIN COGNIZANCE OF LICENSEE PERFORMANCE.
