CHAIRMAN MESERVE: Good morning. This is an affirmation session and we have one item to come before us. Madam Secretary, you may proceed. MS. VIETTI-COOK: The Commission is being asked to act on a Memorandum and Order responding to motions by the Citizens Awareness Network (CAN) and the Town of Cortlandt filing jointly with the Hendrick Hudson School District related to the unavailability of the full license transfer application seeking the Commission's authorization for Consolidated Edison Company of New York (ConEd) to transfer the licenses for two nuclear power plants, the Indian Point Nuclear Generating Station, Units 1 and 2, to Entergy companies. The Commission has voted to approve a Memorandum and Order which declines to suspend or terminate the proceeding, but directs ConEd and Entergy to give CAN and Cortlandt access to an unredacted version of the transfer application and grants CAN and Cortlandt an additional 20 days, after obtaining the unredacted application, to submit (or revise) the issues challenging the Entergy companies financial and technical qualifications to own and/or operate the Indian Point 1 and 2 facilities.
