CHAIRMAN MESERVE: Why don't we get started? I have to apologize to the Advisory Committee that we were testifying, or I was testifying this morning and I fortunately had lots of reinforcements behind me, but mainly my colleagues here at the table, and it went considerably longer than we had anticipated. We do have two minor business items we need to clear up first-affirmations. Madam Secretary, you may proceed.

MS. VIETTI-COOK: The Commission is being asked to act on a Memorandum and Order responding to an appeal by the Connecticut Coalition Against Millstone and the Standing for Truth About Radiation Foundation of the Atomic Safety and Licensing Board's decision in LBP-01-10 which found the petitioners' sole contention to be inadmissable.

The Commission has voted to approve a Memorandum and Order which affirms the Board's decision in LBP-01-10. Would you please affirm your votes?

CHAIRMAN MESERVE: Aye.

COMMISSIONER DICUS: Aye.

COMMISSIONER DIAZ: Aye.

COMMISSIONER MERRIFIELD: Aye.
