The Commission is being asked to act on an Order and Memorandum responding to referral to the Commission in a March 10, 2003 Order by the Atomic Safety and Licensing Board of a Partial Initial Decision on air crash probability at the proposed Private Fuel Storage spent fuel facility in Utah. The Commission has voted to approve a Memorandum and Order which holds further Commission review in this matter in abeyance until the Board has completed its "consequences" review. The Commission will review all issues relating to air crash risk at that time and directs the Board to expedite its consequences review. Would you please affirm your votes please?
