ANNETTE VIETTI-COOK: Chairman Diaz, are you on the line?

CHAIRMAN DIAZ: Hello, this is Chairman Diaz.

ANNETTE VIETTI-COOK: Terrific. We have Commissioner Merrifield on the line as well.

ANNETTE VIETTI-COOK: I have two items for affirmation. Can you hear me well Chairman Diaz?

CHAIRMAN DIAZ: Yes. Well.

ANNETTE VIETTI-COOK: Can you hear me Commissioner Merrifield?

COMMISSIONER MERRIFIELD: Yes.

ANNETTE VIETTI-COOK: Ok. Louisiana Energy Services is the first item for affirmation. The Commission is being asked to act on a Memorandum and Order responding to a petition for review filed by intervenors Nuclear Information and Resource Service and Public Citizen of the Atomic Safety and Licensing Board decisions in LBP-06-08 and LBP-06-09. At issue is the adequacy of the NRC staff's analysis, under the National Environmental Policy Act, of the impacts of disposing of depleted uranium associated with the proposed National Enrichment Facility.

The Commission has voted to approve a Memorandum and Order which affirms the Board decisions in LBP-06-08 and LBP-06-09.

ANNETTE VIETTI-COOK: Would you please affirm your votes?

COMMISSIONER MCGAFFIGAN: Aye.

COMMISSIONER JACZKO: Aye.

COMMISSIONER LYONS: Aye.

ANNETTE VIETTI-COOK: Ok. The second item is on Andrew Siemaszko. The Commission is being asked to act on a Memorandum and Order responding to an appeal by the NRC staff of the unpublished Licensing Board Order dated December 22, 2005 in which the Board granted discretionary intervention to the petitioners, Union of Concerned Scientists and Ohio Citizen Action.

The Commission has voted to approve a Memorandum and Order which vacates the "discretionary intervention" portion of the Board's December 22, 2005 order, remands the discretionary intervention issue to the Board, and directs the Board to reconsider the issue in light of the views expressed in today's decision. Commissioner Jaczko has offered a separate dissenting opinion.
