CHAIRMAN KLEIN: Well, Ed, I understand that you're on the phone.

COMMISSIONER MCGAFFIGAN: I am.

CHAIRMAN KLEIN: Welcome, and I'll see you shortly. Any comments before we start. Madam Secretary, would you like to begin.

ANNETTE VIETTI-COOK: We have two items for affirmation. The first item is on Vermont Yankee Nuclear Power Station and Pilgrim

Nuclear Power Station. The Commission is being asked to act on a Memorandum and Order responding to two appeals by Massachusetts Attorney General concerning fire hazards in high-density spent fuel pools. These appeals were filed with respect to the separate decisions of two Atomic Safety and Licensing Boards (LBP-06-20 and LBP-06-23) in two license renewal proceedings. The Commission has voted to approve a Memorandum and Order which affirms the Licensing Boards' decisions in LBP-06-20 and LBP-06-23. Would you please affirm your votes?
