The Commission is being asked to act on a Memorandum and Order responding to appeals by the NRC staff and the applicant, Crow Butte Resources, Inc. (Crow Butte) of the Atomic Safety and Licensing Board decisions in LBP-08-6 and LBP-09-1. The Commission has voted to approve a Memorandum and Order which affirms in part and reverses in part the Board's decisions. Would you please affirm your votes?
