#### PROCEEDINGS

CHAIRMAN JACZKO: This is a formal Commission meeting for the Affirmation Session first and then we'll have Agenda Planning.

MS. VIETTI-COOK: You ready?

CHAIRMAN JACZKO: Yes.

MS. VIETTI-COOK: The first item is the final rule requirements for distribution of byproduct material. The Commission is being asked to act on a final rule amending Title 10 of the Code of Federal Regulations 10 CFR Parts 30, 31, 32, 40, and 70 to revise the regulations to make the requirements for distributors of byproduct material clearer, less prescriptive, and more risk-informed and up to date. The final rule also redefines the categories of devices to be used under exemptions, adds explicit provisions regarding the sealed source and device registration process, and adds flexibility to the licensing of users of sealed sources and devices. The rule also makes licensing processes more efficient and effective. The Commission (with Chairman Jaczko disapproving in part) has voted to approve the publication and implementation of this final rule, subject to removing the quantity limit for the new class exemption, revising the statements of consideration to clarify that the basis for the misuse criteria is safety, and making the changes noted in the attachments. Would you please affirm your votes?

The Commission is being asked to act on a final rule amending 10 CFR Parts 71 and 73 to require licensees to provide advance notification to participating Federally-recognized Tribal governments prior to shipping irradiated reactor fuel and certain radioactive wastes through Tribal reservations. The Commission has voted to approve the publication and implementation of this final rule subject to the changes noted in the attachment. Would you please affirm your votes?
