List of Approved Spent Fuel Storage Casks: Holtec International, HI-STORM Underground Maximum Capacity Canister Storage System, Certificate of Compliance No. 1040: Direct Final Rule; 10 Code of Federal Regulations (CFR) Part 72 (Regulation Identifier Number (RIN) 3150-AJ42; NRC-2014-0120)

On November 19, 2014, the NRC published a document in the *Federal Register* ([79 FR 68763](#)) withdrawing a direct final rule ([79 FR 53281](#)) that would have revised its spent fuel storage regulations to include the Holtec International HI-STORM Underground Maximum Capacity (UMAX) Canister Storage System, Certificate of Compliance No. 1040, to the “List of approved spent fuel storage casks.” The NRC took this action because it received at least one significant adverse comment in response to the companion proposed rule ([79 FR 53352](#)) that was concurrently published with the direct final rule. The withdrawal of this direct final rule became effective on November 19, 2014.

Radiation Protection: Advance Notice of Proposed Rulemaking (ANPR); Extension of Comment Period; 10 CFR Part 20 (RIN 3150-AJ29; NRC-2009-0279)

On November 20, 2014, the NRC published a document in the *Federal Register* ([79 FR 69065](#)) extending the public comment period for an ANPR published in the *Federal Register* on July 25, 2014 ([79 FR 43284](#)). The ANPR was published to obtain input from stakeholders on the development of a draft regulatory basis. The draft regulatory basis would identify potential changes to the NRC’s current radiation protection regulations. To allow members of the public and other stakeholders additional time to comment, the public comment period on the ANPR has been extended from November 24, 2014, to March 24, 2015.
